ORDER:

In the Government Order read above, among other things, orders were issued amending the Special Rules for the Tamil Nadu General Subordinate Service in class XLIII Department of Economics and Statistics in Rule 4, five years of service in the post of Assistant Statistical Investigator, including three years of field service in the districts other than Chennai District has been specified.

2. In the letter read above, the Principal Secretary/ Commissioner, Department of Economics and Statistics has stated that the reason for excluding Chennai District is that the agricultural schemes which form the bulk of data collected by the department are not implemented in Chennai District. He has further stated that the Assistant Statistical Investigators in Chennai District are being engaged in collection of other important socio economic data through the Prices and National Sample Survey Schemes and these data collection methodologies have their own special features and challenges and are comparable to agricultural schemes in terms of their importance to the economy. Hence, he has requested the Government to include the service rendered in Chennai District as field service.

Government after careful consideration, accept the proposal of the Principal Secretary/Commissioner of Economics and Statistics and accordingly include the service rendered in the post of Assistant Statistical Investigator in Chennai District as field service for the promotion as Statistical Inspector.
