#### **ORDER:**

The Managing Director, Tamil Nadu Salt Corporation Limited has submitted a report on damages caused to the Salt Works at Mariyur, Valinokkam, Ramanathapuram District on account of Tsunami that struck on 26.12.2004.

2. The Managing Director ,Tamil Nadu Salt Corporation Limited has therefore requested for sanction of a sum of Rs. 1.50 crores.
3. The above proposal was placed before the State Level Committee for Calamity Relief Fund Schemes in the meeting held on 13.4.2005. The Committee considered the proposal of the Managing Director, Tamil Nadu Salt Corporation Limited and decided to sanction a sum of Rs. 10 lakhs from the Calamity Relief Fund for restoring the cross bunds inside the salt works damaged by Tsunami and the committee noted the need for waiver of additional royalty but suggested that the Salt Corporation may take up the issue with Government in Industries/Revenue Department.
4. The Government after careful examination accept the recommendation of the State Level Committee on Calamity Relief Fund Schemes and accordingly sanction a sum of Rs.10 lakhs (Rupees Ten lakhs only) to the Tamil Nadu Salt Corporation Ltd for restoring the cross bunds inside the salt works affected due to Tsunami.
5. The amount sanctioned in para 4 above shall be debited under “2245 Relief on account of natural calamities 80 General 800 other expenditure - I Non Plan AB Assistance for undertaking relief works in connection with Tsunami affected areas 09 Grants in aid 01 Grants for current expenditure (DPC 2245 80 800 AB 0918).

6. The Special Commissioner and Commissioner of Revenue Administration is authorised to draw and disburse the amount sanctioned in para 4 above as per the existing procedure to the Managing Director, Tamil Nadu Salt Corporation Limited, Chennai 600 002 and to send the utilisation certificate to Accountant General/Government.
