ORDER:-

In the G.O. first read above, the Government have accorded administrative sanction for the implementation of ETRP with World Bank Assistance at a cost of **Rs.1852.72 Crores** for Housing Reconstruction, Restoration of livelihood, repairs and reconstruction of Public Buildings, Providing Technical Assistance and Training and Implementation Support for Tsunami affected victims.

2. In the G.O. second read above, the Government have constituted an Empowered Committee to clear the projects to be implemented with the grant / assistance from ADB and World Bank.

3. In the G.O. third read above, a Project Implementation Unit headed by a Project Implementation Officer, Chennai has been formed in Rural Development Department for the implementation of the Externally Aided Project of Tsunami Emergency Assistance Project (TEAP) funded by Asian Development Bank, Emergency Tsunami Reconstruction Project

(ETRP) funded by World Bank and Post Tsunami Sustainable Livelihood Programme (PTSLP) funded by IFAD in the Tsunami affected coastal districts.

4. The Project Implementation officer, Tsunami Project Implementation unit, Rural Development and Panchayat Raj Department has submitted proposal for the sanction of additional staff at a cost of Rs.5.63 crores before the Empowered Committee held on 9.2.07. The Project Implementation officer has justified that these additional staff are required to take up the construction of 15,869 houses in vulnerable areas in 11 coastal districts of the State under the Rajiv Gandhi package and further about 25,000 vulnerable houses proposed to be taken up under ETRP. The total value of works currently being taken up amounts to Rs.796.95 crores.

5. For the construction of the houses under ETRP the preliminary works like identification of sites, preparation of layouts, Plan preparation, Estimates Preparation, etc. are to be done immediately to take up the project. It is expected that these works can be taken up sequentially after the initial works are completed. The staff already sanctioned for TEAP programme is unable to take the additional work. Regular RD staff are also unable to take these works because they are already implementing schemes over and above their capacity. Hence sanction of additional staff is absolutely essential. He has therefore requested to sanction certain additional staff. The Officer on Special Duty (Relief and Rehabilitation), Chennai has placed the above proposal to the Empowered Committee.

6. The Empowered Committee in its meeting held on 9.2.07 directed that the staff proposal of line departments be examined separately by the Sub- Committee with respect to actual requirements and funds provided under implementation support of the project. The Sub-Committee, approved the proposal of the PIO /TPIU restricting the number of posts as given in the Annexure to this order for execution of schemes by Rural Development and Panchayat Raj Department under ETRP.

7. The Government, after careful examination, decided to accept the decision of the Sub Committee and sanction additional staff at a cost of **Rs.372.76 lakhs (Rupees Three hundred and seventy two lakhs and seventy six thousand only)** detailed in the **Annexure – I** and **Annexure II** to this order for TPIU, Chennai and DIUs in Tiruvallur, Kancheepuram, Villupuram, Cuddalore, Nagapattinam, Thoothukudi, Tirunelveli and Kanniyakumari Districts for execution of schemes by Rural Development and Panchayat Raj Department under TEAP for a period of one year from the date of filling up of the posts. The expenditure for the Posts sanctioned under this Government order will be met from TEAP funded by Asian Development Bank.

8. The Engineering staff and administrative staff sanctioned for PIU will be on deputation to TPIU, Chennai, and Engineering staff and administrative staff sanctioned for DIUs will be on deputation to DIUs. The staff sanctioned above are eligible to draw their grade pay and allowances including project allowance in accordance with orders admissible in force.

Orders of Deputation, terms and conditions for the staff shall be issued separately by the respective departments in accordance with the orders in force.

9. The salary and other expenditure shall be disbursed by the Project Implementation Officer, Tsunami Project Implementation Unit, Chennai to the District Implementation Units/ Tsunami Project Implementation Unit, Chennai. The Project implementation Officer is permitted to adopt any modes of recruitment / deputation in consultation with Secretary, Rural Development and Panchayat Raj Department. The Project Implementation Officer is also permitted to redeploy the sanctioned staff based on the needs of the District Implementation Units in consultation with Secretary to Government, Rural Development and Panchayat Raj Department.

10. The expenditure sanctioned in paragraph 7 above shall be debited to the following head of account:-
