ORDER:

While moving the Demand for Tourism, for the year 2013-14, the Hon'ble Minister for Tourism has made the following announcement in the Legislative Assembly.

"The Hon'ble Chief Minister has ordered to provide basic facilities at 14 important tourist centres, at a total cost of Rs.10.58 crores... including Thirukovilur in Villupuram District."

2. In the letter second read above, the Principal Secretary/ Commissioner of Tourism has stated that the District Collector, Villupuram has sent a proposal for "Provision of Tourist Infrastructure facilities at Thirukovilur, Villupuram District" at a total cost of Rs.127.00 lakhs and requested to sanction funds from Tourism Department to carry out the following components of works:-

- 3. The Principal Secretary/Commissioner of Tourism has also stated that the proposal of the District Collector, Villupuram has been examined in detail and considering the importance of the place and also to implement the announcement in the Tourism Demand 2013-2014, he requested the Government to consider and approve the proposal for "Provision of Tourist Infrastructure facilities at Thirukovilur, Villupuram District" and sanction a sum of Rs.127.00 lakhs, to carry out the works.
- 4. The Government after careful examination of the proposal of the Principal Secretary/Commissioner of Tourism have decided to accept and accordingly issue the following orders:
 - i. Sanction is accorded to the Principal Secretary/Commissioner of Tourism for a sum of Rs.127.00 lakhs (Rupees one crore and twenty seven lakh only), for provision of infrastructure facilities at Thirukovilur in Villupuram District, as mentioned at para 2 above.
 - ii. The Principal Secretary / Commissioner of Tourism is authorized to draw the amount sanctioned above and permitted to disburse it to the District Collector, Villupuram, to execute the works through Thirukovilur Town Panchayat.
- 5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-
 - "5452-Capital Outlay on Tourism-01-Tourist Infrastructure-101-Tourist Centres Schemes in the Twelfth Five Year Plan-II State Plan-KV Improvement of basic facilities in Tourist Centres 16 Major Works" (DPC 5452 01 101 KV 1604).
- 6. The expenditure is on "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be met by advance from the contingency fund orders regarding which will be issued in the Finance (BG-I) Department. The Principal Secretary /Commissioner of Tourism is requested to send necessary application in the prescribed form together with a copy of the Government Order to Finance (BG-I) Department for sanction of advance from Contingency Fund. He is also requested to send the draft supplementary notes indicating the cost of the scheme with the explanatory notes therefore to the Finance Department.
- 7. The Principal Secretary/Commissioner of Tourism shall ensure that necessary arrangements are made in the proposed infrastructure facilities at Thirukovilur in Villupuram District, to visibly indicate that the above works were carried out through "STATE TOURISM DEPARTMENT FUNDS".
- 8. The Principal Secretary / Commissioner of Tourism shall send a report on the progress of above works and Completion Report / Utilization Certificate to Government.

9. This order issues with the concurrence of Finance Department vide its U.O. No.67482/Edn.II/2013, dated: 27.11.2013 with Additional Sanction Ledger No.2074 (Two thousand and seventy four).
